SAN LUIS OBISPO COUNTY BUILDERS EXCHANGE
SCHOLARSHIP RULES AND REGULATIONS

1. ELIGIBILITY

- A. Any high school senior graduating from a San Luis Obispo County high school, who is pursuing a career in the construction and building industry at a college, university or trade school; or a current student or returning student pursuing such a career at Cuesta College or Cal Poly, San Luis Obispo. To be eligible, the student must be the child or grandchild of a member of the Builders Exchange, an employee of a member, or a child of a member's employee. The applicant should also carry a minimum of twelve credit hours to be deemed a full time student and should be studying construction, engineering, architecture or a similar aspect of construction. Students attending a trade or technical school are also eligible.
- B. Any individual applying for benefits must be eligible to enter college/trade school in September of the year in which the application is made.
- C. Any individual applying as a full time student for a scholarship must submit a completed application form, copies of which may be obtained at the San Luis Obispo County Builders Exchange, 153 Cross St., #130, San Luis Obispo, CA 93401
- D. Applicants will be judged on GPA, SAT scores, extra activities, work experience, industry interest, need, and recommendations.

2. SPECIFICS

- A. All application must be received by the deadline given in the cover letter. Applications received after will not be considered. Incomplete applications will not be considered.
- B. The award shall equal the value of one thousand dollars (\$1,000). The number of scholarships awarded is decided solely by the Scholarship Committee.
- C. Awards will not be paid to the recipients directly. Funds will be disbursed upon receipt of a statement from the recipient's school, and paid directly to that school in the name of the recipient.
- D. The Scholarship Committee shall consist of members of the San Luis Obispo County Builders Exchange.
- E. Applicants will be considered regardless of race, creed, color, national origin, or sex.
- F. Any recipient of an award shall be required to submit a pledge form to be countersigned by his or her parents that, in the event the applicant does not attend a college, university, or trade school in the academic term or year for which the scholarship is awarded and take the required courses as stated herein, or should drop out of college or trade school prior to the completion of the academic year, other than by virtue of serious illness or induction into the armed services, the money shall be promptly repaid to the Scholarship Fund.
- G. Applicants at the discretion of the Scholarship Committee may be required to appear for a personal interview at the San Luis Obispo County Builders Exchange Conference Room, 153 Cross St., #130, San Luis Obispo, CA 93401, (805) 543-7330.
